MEETING 27 FEBRUARY 24

MINUTES

Minutes of the previous meeting were confirmed as correct.

LLANYBYDDER MATTERS

THE PARK

Tenders - Tenders were prepared for the Playing Field Contracts for Llanybydder and Rhydcymerau parks which were all displayed in the village and on our website. There were 3 tenders received: £11,260.00 pa, £5750.00 pa, and £3800.00 pa. The tender was awarded to Tomos Evans of T Evans Landscaping, Dolfedw, Llanybydder SA40 9UD at the price of £3800.00 pa plus Vat. Clerk is to notify him of our acceptance of his tender and to arrange a meeting with him and K Jones.

Mr Garside - L Jones was given instruction to remove the fencing that was erected by our Council quite some time ago. Next meeting.

Markings on Tennis Court: D Owen is going to take some photographs and forward them to the Clerk.

Goal posts replacement - Next meeting.

Holey Moley - The mole has been removed. Pay Invoice £111.00 received from D M Evans, Holey Moley.

Park Inspection - Pay Invoice £96.00 from Carms CC for park Inspections. Clerk is to enquire whether Rhydcymerau park is included in this price.

PUBLIC CONVENIENCES

Pay K Jones £376.19 for toilets maintenance & cleaning materials -27/1/24 - 23/2/24 £360.00 + £16.19 for cleaning materials. K Jones informed us he would be away for our next meeting 26/3/24 and asked if he could be paid for his next Invoice £450.00 -24/2/24 - 28/3/24 + £6.63 for cleaning materials = £456.63 on the 26/3/24.

Pay Invoice £3858.12 received from Proclean Wales for the deep cleaning and sanitising all cubicles. Carry out all repairs to all cubicles. Re-decorate all cubicles. Apply 2 coats of anti graffiti coatings to all interior walls. All in accordance with previous quote received.

Pay EDF Invoice £477.09 - 1/1/24 - 31/1/24. The Clerk did meet up with J Furber who very kindly dedicated her time to the Clerk. On speaking to EDF J Furber fully understood what the Clerk had been up against. EDF assured us the account was correct. And the slight difference of around £50.00 between us and EDF appears to have been created due to EDF changes with their dates. As discussed at our previous meeting with regards to a smart meter that may well be the answer, it was decided to go for a smart meter and it was ordered whilst J Furber and the Clerk had their meeting. Confirmation has been received from EDF since for the smart meter appointment to take place on Thursday, 28^{th} March 24. The installer will be arriving between START TIME 8.00 and END TIME 12.00. Appointments usually take 1-2 hours and the engineer will contact the Clerk before arrival to arrange access to site. The supply will be disconnected for approximately 30 minutes for a single-phase meter, and 90 minutes for a three-

phase meter. Someone will need to be present at the premises throughout the install. Kevin Jones will need to make sure that there is nothing blocking access to our meter. The Clerk will be present at the premises throughout the install.

The Clerk received 2 emails from 2 separate people reporting problems at these toilets. The first email pointed out there are a lot of youngsters doing drugs in these toilets from 7pm onwards. The second email pointed out there is a lot of activity in these toilets after 7pm nightly. And after a visit to these toilets there were 3 youths smoking pot in cubicle No 2. On hearing these serious problems, the decision has been made to lock these toilets at 8pm nightly to INCLUDE weekends also. In general most toilets are not in service after this time as this is the cut off time in most villages/towns with public toilets. These toilets will now open at 8am and locked 8pm. D Owen is making enquiries in respect of warning signs outside these toilets.

FLOWERS TENDER

There was 1 Tender received by L Jones for £5175.00pa which was accepted by our Council. Clerk is to notify L Jones by email.

TEN TOWNS

There has been no reply from Carms CC to our request to ask if our Council could be granted permission to park a container on the RFC car park to be used for storage of gazebos etc for the market stalls, so Clerk is to send a reminder. D Owen is going to contact D Mulholland in respect of stalls payments.

XMAS LIGHTS

Clerk is to contact all relevant businesses that had Xmas lights erected by our Council if they could safely store each Xmas light at their premises until next Xmas. A tender will have to be prepared for a new electrician to erect and dismantle the lights in future.

Clerk's earnings have been £1060.80 per month = £12729.60 per annum - £15.30 per hour for 16 hours.

In March 24 the Clerk needs to be awarded the new NALC rate which is £16.67 per hour which will be backdated to 1/4/23, under Point 23 of the NALC scales which are applicable to the Clerk.
